

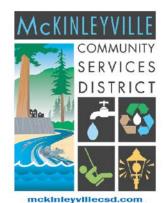

AGENDA ITEM IV – Recreation Director Report

The childcare program has been running since June 1st. We started with one site serving 12 children and have increased to two sites serving a total of 24 children. Staff and participants have adjusted to the new protocols of increased handwashing and sanitizing. Staff have implemented activities and made changes to old activities that children can enjoy while practicing social distancing. Directed drawing, games using white boards, obstacle courses and rollerskating are a few examples.

Parks crews are working to catch up on Central Ave. OSMZ and other OSMZ's after limiting their work in the public open spaces at the onset of the Shelter in Place order. The loss of contracted labor through Northern Humboldt Employment Services and the County Sheriff Work Alternative Program due to the shelter in place order has had a significant impact on the Parks Crew's ability to keep up with landscape maintenance. It is anticipated that the contract services will be able to resume in early July.

As of the writing of these notes the County Public Health Dept. did not have an estimated date or timeline for re-opening picnic areas, playgrounds and community centers.
