
AN ORDINANCE DELETING A SECTION OF ORDINANCE NO. 17

BE IT ORDAINED by the Directors of the McKinleyville Community Services District , Humboldt County, California, as follows:


Article II, Section 2.06 of Ordinance No. 17, known as Industrial Cost Recovery is hereby rescinded, deleted and declared null and void.
