BE IT ORDAINED by the Board of Directors of the McKinleyville Community Services District, Humboldt County, California, as follows:

Ordinance No. 17 Article II, Section 2.01 is hereby modified and amended to read as follows:

Section 2.01. <u>Rate Schedule</u>. Sewer service charges are hereby prescribed as follows:

After a six (6) month period the deposit shall be refunded to property owners with good payment records as determined by the District.

The attached Ordinance No. 23 serves two purposes. One, the addition of charges for septage as required under the terms of the Clean Water Grant Program. Two, the addition of a \$25.00 deposit for sewer service. As suggested by Director Ramey, the addition of a \$25.00 deposit with the \$20.00 deposit for water service will make a total of \$45.00. These can be applied separately for water and/or sewer only.

The septage charges are as per the engineer's recommendation in the revenue program and as required by Water Resources for grant payments beyond 90%.

Bill Cooke will have a schedule for adoption and a projected effective date for the Ordinance.
